



Cases related to nationalities




Elisabeth Sándor-Szalay has acted in a total of **3,348 complaints** since the beginning of her public law mandate taken up a **decade ago**. In 2023, along with the increase of the number of complaints, the proportion of complaints concerning the domestic Roma community and the structural problems of welfare systems also increased significantly. With this in mind, the Minority Ombudsman has stepped up her professional contact activities: wars, various crises, and growing social and international tension all indicate that it is extremely important to talk to each other and, in addition to expressing our professional position, to inform, at the same time, listen and understand the other party as well.

Distribution by topics


